Gift Aid Guidelines and Notes

Gift aid is a government scheme which allows the MBS Annual Fund to claim an additional 25% on gifts made by UK tax payers at no extra cost to you.

On gifts large and small, regular or one-off, we can reclaim the tax from HM Revenue and Customs, meaning your gift to the MBS Annual Fund can make an even greater impact. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
